CAPALF Award Descriptions

Professor Keith Aoki Asian Pacific American Jurisprudence Award

The Professor Keith Aoki Asian Pacific American Jurisprudence Award was established by the Conference of Asian Pacific American Law Faculty in honor of the life and achievements of Keith, who was an outstanding and inspirational teacher, scholar, activist, musician and artist at UC Davis, the University of Oregon, and many other places. Keith was an early and active member of CAPALF.

The Aoki Award will be given to an outstanding individual who, like Keith, has written or advocated on behalf of Asian Pacific American rights, or explored Asian Pacific American identity, history, or rights through law or in other forms.

Professor Chris Kando Iijima Teacher and Mentor Award

The Professor Chris Kando Iijima Teacher and Mentor Award was established by the Conference of Asian Pacific American Law Faculty in honor of the life and achievements of Chris, who was a CAPALF member and a beloved and distinguished teacher and scholar at the NYU School of Law, Western New England School of Law, and the University of Hawai'i Richardson School of Law.

The Iijima Award will be given to an outstanding law teacher who, in the course of her or his career, has achieved excellence in the areas of public service and teaching, with some consideration of scholarship. The Award is particularly aimed at law teachers who have provided support, encouragement and mentoring to colleagues, students and aspiring legal educators.

Professor Eric K. Yamamoto Emerging Scholar Award

The Professor Eric K. Yamamoto Emerging Scholar Award was established by the Conference of Asian Pacific American Law Faculty in honor of the achievements of Eric, who is an internationally-renowned authority on issues of redress and reconciliation. He has written and spoken extensively about how healing the wounds of past injustice by "doing justice" now can reach deeply into a nation's social fabric.

The Yamamoto Award will be given to an early-career law professor at any law school in the United States who demonstrates outstanding promise.

NEPOC Award Descriptions

The Kellis Parker Keynote

Kellis E. Parker, one of five black students who integrated the University of North Carolina, later graduated from Howard Law School. In 1972, after teaching clinical programs at UC Davis Law School, he became the first black law professor at Columbia Law School where he was beloved by students and where, in 1994, he was named to an endowed position, the Isidor and Seville Sulzbacher Professor of Law. He also served, for a year, as the Director of the NAACP Legal Defense and Education Fund. He was an outspoken advocate for ending racial discrimination in academia, a talented musician (he embraced jazz as a framework for understanding law), and a mentor for many people of color in law teaching today. Kellis passed away in October 2000.

Each year, NEPOC selects an outstanding individual or two to deliver the Kellis Parker keynote address.

Haywood Burns/Shanara Gilbert Award

Haywood Burns got his start in social justice work not as a lawyer, but as a teenager who successfully helped desegregate a swimming pool in Peekskill, NY, his home town. He participated in Freedom Summer, going to Mississippi in 1964 to register voters. In 1969, he helped found the National Conference of Black Lawyers. He was a trustee for the Center of Constitutional Rights, represented the black radical Angela Davis against charges of kidnapping and murder, and coordinated the defense for inmates indicted in the Attica prison riot. And he was a dean at CUNY Law School.

Shanara Gilbert was an Associate Professor of Law at CUNY Law School and founded its criminal defense clinic.

In 1996, the Planning Committee for the first NEPOC asked Professor Burns to serve as moderator of a panel. Several days before the Conference, Professor Burns left a message on Planning Committee member Leonard Baynes' answering machine apologizing for canceling his commitment, stating that he had been called by President Nelson Mandela to do more work on the South African Constitution, and that he owed Len one for renegeing on his commitment. Tragically, Professor Burns, along with Professor Shanara Gilbert, was killed in a car accident during their trip to South Africa.

In recognition of their contributions, NEPOC created the Haywood Burns/Shanara Gilbert Award, which each year is given to a law professor who has demonstrated the same values, courage, and civic commitment that our esteemed deceased colleagues exemplified throughout their lives.
