#### **Scholarship**

My scholarship focuses on adapting international intellectual property rights (IPR) enforcement models to a changing global marketplace. The present dominance of the World Trade Organization (WTO) in international IPR dispute resolution invites particular focus on that entity, raising questions such as (1) the effectiveness and sustainability of a complex, slow-moving multilateral system in an increasingly borderless and fast-paced trade environment; (2) whether changes in trade law should influence the WTO's mandate with respect to regulation of IPR; and (3) whether emerging models of enforcement should complement or supplant the WTO's state-centered system. These questions have ramifications beyond IPR enforcement and international trade law, also impacting broader international law debates about flexibility of instruments, compliance and dispute resolution.

Toward a TRIPS Truce, 32 MICH. J. INT'L L. \_\_\_\_ (forthcoming 2011)(draft available upon request). This article addresses the continued utility of the WTO's Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPS) in a world dominated by technological change, decreasing territoriality and stark disagreements about IPR objectives among TRIPS signatories. I argue that TRIPs remains viable despite these phenomena, using recent WTO jurisprudence to suggest an element of adaptability in the agreement that can keep it current and move divergent constituencies toward their respective goals. This development strengthens the WTO's position as an IPR enforcement regime and provides a path for reconciliation of WTO members' largely incompatible IPR agendas.
