Founded in 1986 by Professor Elizabeth Schneider, the Edward V. Sparer Public Interest Law Fellowship program prepares lawyers to work for social justice. The Fellowship was named in honor of the late Ed Sparer, Professor of Law and Social Welfare at the University of Pennsylvania Law School, and a graduate of Brooklyn Law School in the class of 1959. The Fellowship provides fellows with a grant to support their summer internship with a public interest organization in the U.S. or abroad. Fellows also take an active role in hosting monthly luncheons that highlight current public interest issues, helping to plan academic events, and supporting the public interest community at the law school.
